

Management of the Foundation

CCB Foundation successfully completed the 15th year of its journey towards successful existence. During this period of fifteen years the Foundation has achieved reasonable success to make its projects reasonably sustainable. During the period the Foundation has identified a substantial number of merits among poor students and continues its activities to support and nurture these merit with financial assistance and encouragements. In its approach to assist social problems, the Foundation has adopted legal aid programmes under which the Foundation can claim to have establish some principles of law from the Supreme Court of Bangladesh and also has sought intervention towards the way to create legal justice for rape victims, victims of other crimes and RTI Activism. Some of the important links of our works are given below:

Management of the Foundation:

According to the Articles of Association of the Foundation, a Board of Directors shall manage and administer the Foundation. The Governing Body is composed of the members with the proviso that the total number of members shall not exceed 27. At present there are five members in the Governing Board. The term of the Board is for two years. Therefore, the election of the Board is held every alternate year. The Governing Board has the responsibility to determine the direction and scope of the activities of the Foundation. It also has the responsibility to approve projects and to approve and administer the annual and supplementary budgets. The Governing Board exercises full management and financial control of the Foundation. At present the Board of Directors consist of the following persons: (1) Mr. Barrister Md. Legal Team:

The Foundation has its legal team which works in the Supreme court to defend rights of the poor and marginalized in the society. The Foundation has also set its network to assist victims of injustice, victims of rape, victims of gross human rights violations. This team includes Barrister Md. Abdul Halim (Hon. Chairman), Advocate Jamiul Hoque Faisal (Director, legal), Ishrat Hasn (Director, Legal), Barrister Golam Ayub Avro (Legal Expert Associate).
